## Confidentiality

- ✓ Through a series of robust access controls, only the right people will have the right access to data.

## Integrity

- ✓ Control is tightened by limiting the ability to alter or destroy information.

## Availability

- ✓ All data must be available to authorized individuals whenever it's needed.

## UK Cyber Essentials

Cyber Essentials is a simple but effective, United Kingdom National Cybersecurity Centre (NCSC) backed scheme for protecting an organization, whatever its size, against a whole range of the most common cyber attacks. Cyber Essentials certification has become a requirement for bidding commercial and government contracts in the UK.

## General Data Protection Regulation

GDPR is a regulation that harmonizes national data privacy laws throughout the EU and enhances the protection of all EU residents with respect to their personal data. This harmonization creates new rights for individuals and a set of stronger and clearer rules for businesses.

## Health Insurance Portability and Accountability Act

HIPAA comes with a series of regulatory standards that outline the lawful use and disclosure of protected (aka personal) health information (PHI). HIPAA compliance is regulated and enforced by the US government.
