

# FAQs


## 1. Is SecureSignature legally binding?

Yes, it is designed to support legally binding agreements. However, we are not yet ESIGN or eIDAS compliant. Compliance enhancements are in progress.

## 2. Does it include an audit trail?

The first release includes real-time status tracking. A per-document audit report will be available in our upcoming v47 release.
