

Thank you for checking out our 2nd issue of the FDSS Newsletter! We have made substantial progress since Issue 01 that we're excited to share. PAL Stage 2 has been fully approved, and we have released Phase 1 of the main Design, Development, and Implementation (DD&I) Procurement to the vendor community in October. Our search for a contractor to build the FDSS has begun!

Phase 2 will begin in January and over the next 6-8 months, vendors will be creating their development proposal and a demo FDSS product for the State to evaluate. At the end of this procurement period, a vendor will be selected to begin building FDSS. Check out the FAQs for more information on Phases 1 and 2.

We read all your comments and implemented many of your suggestions. We're grateful for your knowledge and expertise. - •You may be wondering what happened with renaming FDSS. First, thank you all for voting. There was a clear winning name but among all the CDPH acronyms, CNDR (California Neurodegenerative Disease Registry) was already taken. - •The Data Assessment RFO Procurement is inching closer to its release in a selected vendor community! The contract is expected to begin in Jan. 2024.

FAQs

•Q: Once the DD&I Procurement is released, what happens?

A: Once the Procurement is released, we will spend 6-8 months conducting the procurement with our California Department of Technology (CDT) partners. Phase 1 will open the procurement to the vendor community where any vendor can bid with their proposed solution in a written response. Phase 2 will begin with the selection of the top 3 vendor proposals to move forward and create a proof of concept demo product. At the end of the procurement period, a vendor will be chosen and begin 2 years of system development before FDSS goes live!

•Q: What are the other procurements for?

A: Design, Development, & Implementation (DD&I): Main contractor to create FDSS.

Data Assessment and Planning (DAP): Ancillary vendor to complete a data environment assessment of CalREDIE, complete data cleaning, and make a recommendation on legacy data migration.

Independent Verification and Validation (IV&V): Ancillary vendor to make sure project vendors are in compliance with scope and contracts.

Project Management: Ancillary vendor to provide project management services to make the project remains on schedule, within scope, and within budget.

Organizational Change Management and Training (OCM): Ancillary vendor to work with CDPH and LHJs to prepare users for cutover and provide training.
