Immunizations Before Summer Travel

Encourage families planning summer travel to get caught up on immunizations at least a month beforehand. Protect patients against measles, pertussis, and other diseases causing recent outbreaks. If you do not stock certain travel vaccines, direct patients to a travel medical clinic.

MMR Vaccination Guidance Reminders

Before international travel

- All ages: up to date measles vaccination
- Ages 6-11 months: 1 dose before departure, then routine 2-dose series
- Age 12 months and older: First dose now, 2nd dose 28 days later

Before domestic travel

For people who live in or visit domestic measles outbreak areas, some state and local health departments might recommend:

- Early MMR dose at age 6-11 months
- 28-day interval between MMR dose 1 and 2

A New Dose Regimen of Paxlovid Is Now Available

A new dose regimen of Paxlovid is now available for the treatment of mild to moderate COVID-19 in patients who have severe renal impairment (eGFR <30 mL/min, including those who require hemodialysis). This new Paxlovid dose pack will be covered under the U.S. Government Patient Assistance Program (PAP) operated by Pfizer, which provides free Paxlovid to eligible uninsured or underinsured patients. For details on the program, including eligibility and enrollment, please visit the Paxcess website.

Federal entities can order the new dose pack of Paxlovid for patients with severe renal impairment as part of their monthly Paxlovid threshold in the Health Partners Ordering Portal (HPOP). For patients with severe renal impairment, Paxlovid is taken per the prescribing information: only once a day for 5 days, at the same time each day, on the following schedule:

(one 100 mg tablet) ONCE. 2. Days 2 through 5: Take 150 mg nirmatrelvir (one 150 mg tablet) with 100 mg

1. Day 1: Take 300 mg nirmatrelvir (two 150 mg tablets) with 100 mg ritonavir

ritonavir (one 100 mg tablet) ONCE. On days that patients undergo hemodialysis, Paxlovid should be administered after
