National Immunization Awareness Month: Older Adults



We are observing the final week of National Immunization Awareness Month and this week we are highlighting immunization for older adults. Older adults have weaker immune systems, so it's important to keep them up to date with their vaccines.

With respiratory virus season just around the corner, make sure to protect your patients by vaccinating them against <u>flu, COVID-19</u>, <u>and RSV</u>. Complications from these diseases are very dangerous, especially for older adults! Getting annual flu and updated COVID-19 vaccines can help them from getting severely ill or hospitalized. A <u>second dose of COVID-19 vaccine</u> is also recommended for older adults 65+ at least 6 months after their latest dose to protect against severe COVID-19 disease.

One dose RSV vaccine is recommended to adults 75+ and now expanded to <u>adults starting</u> <u>at 50 years</u> who are at increased risk for severe RSV disease. Timing is year-round, so you don't have to wait. Offer the RSV vaccine to eligible, unvaccinated adults now!

Here are other tips to make sure older patients are up to date with their vaccines:

- When patients come in for visits, check if they are also due for <u>other recommended</u>
 <u>vaccines</u> like shingles and pneumococcal vaccines.
- Hold vaccine clinic hours for flu, COVID-19, and RSV. They are safe to get at the same time. See Fall-Winter Immunizations Guide for more information.
