'Tis the Season for Respiratory Infections - Vaccinate for Healthy Holidays

With [Influenza \(flu\)](#) and [Respiratory Syncytial Virus \(RSV\)](#) activity rising in [California](#), continue vaccinating against [respiratory diseases](#):

- **Flu and COVID-19:** everyone 6 months of age and older should get updated (2024 – 2025) flu and COVID-19 vaccines.
- **RSV:**
 - All infants 0 – 8 months
 - Young children 8 – 19 months at [high risk](#) of RSV disease
 - Pregnant persons from 32 – 36 weeks gestation
 - Adults 75+ or aged 60 – 74 with immunocompromising conditions

Novavax Turned Off for Ordering

As of November 16, 2024, Novavax ordering has been turned off for CA BAP and VFC due to short expiry dates (current lots have an expiry of 12/31/24). Ordering will be turned back on once CDC has new inventory with a longer shelf-life or if the current lots get approval for a shelf-life extension. An [Expiration Look-Up Tool](#) is available for providers to check for most up-to-date information about expiry administration.

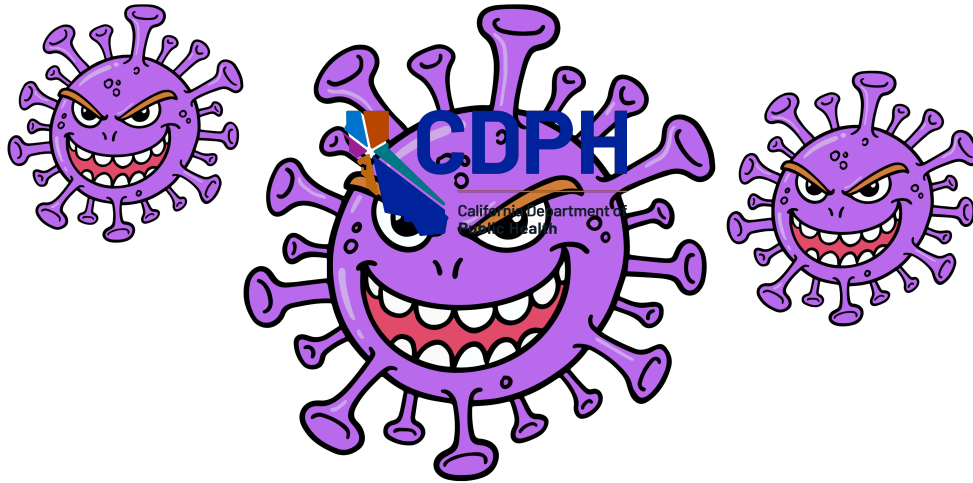
