## Respiratory Illness Updates: It's Not Too Late to Vaccinate!



# **As Whooping Cough Cases Increase, CDPH Encourages Tdap Vaccination**

Whooping cough (pertussis) activity in California is on the rise, with more than 2,000 reported cases and one infant death between the months of January and October of 2024. To protect infants from whooping cough, CDPH strongly urges maternal immunization with Tdap (tetanus, diphtheria, pertussis) vaccine in the last trimester (between 27 and 36 weeks) of every pregnancy.

When given during pregnancy, Tdap is approximately 90% effective in preventing infant hospitalizations due to whooping cough. It is also beneficial for all family members and caregivers of newborns to receive either the Tdap (for adults and children seven years of age or older) or DTaP (for those six years of age or younger) vaccines to prevent spreading whooping cough to infants. These vaccines are safe and effective and can be given at the same time as flu, COVID-19, and RSV vaccines.

Below are Novavax COVID-19 vaccine lots with recent or short expiration dates. Please ensure that all expired vaccines are removed from storage units. Please see expiration date information below:

- Lots expiring in January 2025

- Lots expiring February 2025
  - 6024MF023A

- Lots expiring March 2025

Providers should confirm that vaccines with the earliest expiration dates are placed toward the front of vaccine storage units to ensure that they are used first. Please refer to the <u>manufacturer webpage</u> for information regarding expiration dates.

### Call Center Phone Line Issues Resolved

On Wednesday, January 8, 2025, the call center phone lines began experiencing extreme static, to the point that CSRs could not hear providers on the other line. ## 2025 Vaccines for Children (VFC) Recertification

Recertification on myCAvax was made available on December 19, 2024. The due date is Friday, February 14, 2025.

If Recertification is not submitted by the deadline, program location account will be suspended.

## **U.S. Government Patient Assistance Program (USG PAP): Paxlovid**

Medicare patients will continue to have ways to access Paxlovid medication. Starting January 1, 2025, patients who are covered under Medicaid, Tricare, or Veterans Affairs Community Care Network should consult their plan for coverage. Paxlovid is also on the Medi-Cal Rx Contract Drug List.

Federal entities including DoD health centers, Veterans Affairs health centers, Indian Health Service health centers, and HRSA-supported health centers will access Paxlovid from the HHS supply until that supply is depleted or until December 31, 2028, whichever comes first.

Eligible uninsured individuals who cannot afford the medication also can receive no cost Paxlovid through enrollment in the USG PAP. Pfizer will continue to operate a co-pay assistance program for individuals with commercial insurance.
