It also provides up to GBP25,000 of cover for defence costs you may incur in respect of your professional body's disciplinary tribunals. Other valuable areas of cover are shown below.

- Asbestos: GBP1,000,000 of cover in all, or the policy's indemnity limit, whichever is the lesser amount. Insurance cover has been extended to include any claim relating to your liability for asbestos matters but excludes claims for bodily injury and also claims arising from asbestos surveys
- Loss of documents: GBP250,000 of cover in all.
- Pollution cover: Up to the full limit of indemnity on an aggregate basis.
- Innocent non-disclosure: This provides added protection in the event of your unintentional non-disclosure to insurers of a material fact.
