

In 2022/23 there were 216 successful Health and Safety Executive (HSE) criminal prosecutions with an average fine of £145,000 representing a 94% conviction rate. This included five fines that exceeded £1 million.

We have already seen a number of high profile cases in 2023 suggesting that the figures in relation to fines for 2023/24 are likely to increase significantly. Added to this, businesses continue to face the prospect of paying substantial damages from civil liability claims which can have a significant financial impact on business performance.
